- A) Building & Grounds Committee Update Mr. Delano presented Bill Cherloff, from the district's architect firm. He gave a presentation on the replacement of the windows in the main building and replacement of the Special Education building. He provided information on the different options the district would have on making their decision and cost scenarios for both projects.

 - Ms. Joanne Palisi, Business Teachers has successfully secured several Intern Programs for the district.
 - Lastly, Dr. Youngblood shared that the Peconic Teacher Center has granted Judiann Fayyaz's Landscape & Design Class a maxi grant in the amount of approximately \$1200 for equipment to propagate plants. This grant was written and achieved by Ms. Fayyaz.

She stated that those particular students are an asset to our classrooms, and they help to encourage academic competition among the student body. She asked the Board if they would give consideration to grand-fathering those students into the district tuition-free until they graduated. She also asked if the established tuition rate could be reconsidered and made more affordable, in order for students and families to seek out our district as an educational option, while helping to increase the enrollment to its full running capacity without necessarily affecting the budget.
